Chairman Arias requested a motion to accept all the bank statements, reconciliation documents, the balance sheets, and the Memorandum documents as presented for January 2024. OFDBM McNulty made the motion. OFDBM Walker seconded the motion. All were in favor. Motion passed. Chairman Arias signed all the financial documents.
