Board Communication Memorandums were provided to each Board member prior to the meeting. These had the beginning and ending balances, income, and expenses, for each bank account and the OFD credit card, for March 2023, compared to the total year budget and income. Acosta then went over the bank statements and reconciliation reports for each OFD account (General Fund, Volunteer Pension accounts held at the Pinal County Treasurer's Office, the Chase Bank (payroll account), and the National Bank Visa card. Acting Chairman Arias made a motion to accept the bank statements, reconciliation documents, the balance sheets, and the Memorandum, and PTO and wage documents as presented. OFDBM Hill seconded the motion. All were in favor. Motion passed. Clerk Arias signed all the financial documents.
