WHAT YOUR FIRE DEPARTMENT TAXES HAVE PROVIDED:

- 2004: Completed west truck bay addition
- 2004: Purchased a 3000 gallon water tender
- 2005: Completed office and crew quarter addition
- 2005: Replaced roofing on old building
- 2005: Began hiring full time EMT/firefighters
- 2005: Hired office manager/bookkeeper
- 2006: Provide full time crew benefits ie. health insurance, vacation, sick, etc.
- 2006: Installed 40 KW backup generator and replaced old electrical panel
- 2007: Purchased adjacent vacant lot
- 2007: Completed annexation of 20 square miles, including 3 large proposed subdivisions
- 2007: Remodeled kitchen and dayroom
- 2007: Provide full time crew with Public Safety Pension Plan
- 2008: Completed new exercise room and crew toilet/shower room/kitchen pantry
- 2008: Purchased and installed a reverse 911 auto-dialer system
- 2008: Hired additional full time and part time EMT/firefighters
- 2008: Purchased and installed a 1000 gallon diesel tank with pump
- 2009: Replaced 13 year old Rescue truck
- 2009: Replaced 20 year old fire engine
- 2009: Installed concrete driveway
- 2010: Remodeled east truck bays for use as a training/meeting room
- 2010: Installed new laundry equipment
- 2010: Replaced flooring in dayroom/kitchen/baths
- 2010: Remodeled 35 year old public restrooms
- 2010: Increased staffing levels to minimum 2 person 24/7
- 2011: Purchased 50 x 60 steel storage building
- 2011: Site grading and drainage repairs
